Terms and Conditions for Running of College Canteen for the Academic Year 2018-19

01. The successful Tenderer has to pay rent in advance for whole session in one go failing which the agreement for running the College Canteen shall be terminated without any prior notice.
02. No subletting shall be allowed.
03. Successful Tenderer has to produce a license under food safety and standards act 2006 from the competent authority.
04. Quality of food / edible items shall be subject to regular inspection by College Canteen Committee in addition to the inspection by District level food inspectors. Undesired / expired/un-hygienic Food Items detected in the canteen shall be destroyed on spot.
05. Successful Tenderer has to keep the Canteen and its surroundings neat and clean.
06. Use of polythene and smoking is strictly prohibited inside the college premises.
07. Cigarettes and carbonated drinks are strictly prohibited for sale at the College Canteen.
08. The Canteen is exclusively meant for college students, therefore, no outsider should be entertained at the canteen by the tenderer. Deviation, thereof, shall lead to cancellation of the contract and even warrant a cash penalty of Rs. 1000/-
09. Tenderer has to follow all rules and regulations of the college.
