In pursuance of Government Order No. 209-JK(HE) of 2026 dated 08.07.2026 and the Operational Guidelines issued by the Directorate of Colleges, Higher Education Department, applications are hereby invited from eligible undergraduate students of Semester III to Semester VI belonging to Antyodaya Anna Yojana (AAY) households for grant of Full Fee Waiver for the current academic session.

Eligibility Criteria

Applicants must fulfill all of the following conditions:

1. Be a bonafide student of SHMM Government Degree College Anantnag, enrolled in an undergraduate programme (Semester III to VIII).
2. Belong to an Antyodaya Anna Yojana (AAY) household and possess a valid/updated AAY Ration Card.
3. Not be in receipt of any other scholarship or financial assistance under any Central or UT Government scheme, including the Post-Matric Scholarship Scheme.
4. Be able to establish identity linkage with the AAY household.

Documents Required

Eligible students shall submit the following documents:

1. Duly filled Claim-cum-Declaration Form (Annexure-A).
2. Self-attested copy of the valid AAY Ration Card.
3. Original AAY Ration Card for verification.
4. AAY Certificate issued by the competent authority, wherever available.
5. Self-attested copy of Aadhaar Card.
6. College Identity Card/Admission Proof.
7. Any supporting document establishing relationship with the Head of the AAY household, wherever required.

Applications complete in all respects shall be submitted in the in the Department of English on or before 08-08-2026 during office hours. Regarding I-Semester enrolled students, there will be a separate notice to avail this benefit.
