Subject: Conclusion of Phase-I of Undergraduate Admissions for the Academic Session 2026-27.

The Department of Higher Education, Government of Jammu & Kashmir, announced the commencement of admissions for the Academic Session 2026-27 for Four Year Undergraduate Programs (FYUGP) / 5-Year Integrated P.G. Programs (IPG) with multiple-exit options across all Degree colleges of J&K vide Admission Notification No. DC-HE/2026/1469 dated 02-05-2026 through the Centralised Admission Portal <https://jkadmissions.in>. Allotment proceeded through 12 successive rounds notified vide ref ii-viii above.

The last in-person counselling/walk-in round, scheduled to close on 20-08-2026, shall continue up to 22-08-2026 and colleges shall publish the fresh in-person counselling schedules for leftover seats and seats reclaimed after cancellation/non-payment of fee.

Accordingly the Phase-I of undergraduate admissions for the academic session 2026-27 shall stand concluded on 22-08-2026, and no admission shall be effected after that date. Refund in respect of candidates who have cancelled their admission shall be processed after the closure of Phase-I, in accordance with the refund policy in force.

Phase-II of admissions shall be operated similar to the process conducted in 2025-26 in case the 10+2 biannual results are declared in coming days. The schedule and modalities thereof shall be notified separately upon declaration of the results.
